**RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR TO ENTER INTO A  
MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-REGIONAL  
HEALTH OFFICE IV-A (CALABARZON) FOR THE IMPLEMENTATION OF LOCAL  
POVERTY REDUCTION PLAN (LPRAP) HEALTH PROJECTS**

**WHEREAS**, one of the thrusts of Aquino Administration is to reduce poverty from 26.5% in 2009 to 16.6% by 2015 of the Millennium Development Goal which is reflected in the Philippine Development Plan for 2011-2016;

**WHEREAS**, Executive Order No. 43 S. 2011 involves the organization of Human Development and Poverty Reduction Cluster (HDPRC) the Good Governance and Anti-Corruption Cluster (GGAC), and the Economic Development Cluster that shall implement the Bottom-Up Budgeting (BuB);

**WHEREAS**, BUB ensures the inclusion of the funding requirements for the development needs of poor cities and municipalities in the budget proposals of participating National Government Agencies;

**WHEREAS**, the appropriation for 2015 BUB Projects shall be funded from the General Appropriations Act (GAA) for the year 2015 budget line item under Locally-Funded Projects: Implementation of Various Projects for LGUs;

**WHEREAS**, the Department of Health Central Office had issued Comprehensive Fund Release (CFR) for Calendar Year 2015 to the Regional Health Office No. 4A to fund priority health programs, projects and activities (PAPs) including the implementation of the poverty reduction projects of LGUs in Calabarzon under BUB;

**WHEREAS**, the total amount of Two Million One Hundred Thousand Pesos (Php 2,100,000.00), is intended for the City of Batangas in the implementation of the programs/projects as indicated in their approved Local Poverty Reduction Plan (LPRAP) and GAA for Calendar Year 2015 which shall be allocated as follows:

1. Health Training Program	P 1,134,048.00
2. Job Orientation and Job Placement for Unemployed And Underemployed Health Professionals	P <u>965,952.00</u>
	<b>P 2,100,000.00</b>
