**RESOLUTION GRANTING THE CITY MAYOR THE AUTHORITY TO ENTER INTO A  
MEMORANDUM OF AGREEMENT BETWEEN THE DEPARTMENT OF SOCIAL WELFARE  
AND DEVELOPMENT (DSWD) AND THE CITY GOVERNMENT OF BATANGAS  
REGARDING THE IMPLEMENTATION OF DBM-DILG-DSWD-NAPC JOINT  
MEMORANDUM CIRCULAR (JMC) NO. 1 SERIES OF 2013**

**WHEREAS**, the GPBP which aims to make the planning and budget processes of both local and national government more participatory by involving grassroots communities in the delivery of national services to poor communities be adapted by different National Agencies and Local Government Agencies as part of their poverty reduction effort.

**WHEREAS**, the Sustainable Livelihood Program (SLP) as an innovative approach to livelihood development and people empowerment; Protective Services Program with set of programs and services designed to prevent abuse and exploitation among children, youth, women, person with disability and senior citizen or to provide treatment and rehabilitation to victims and survivors of abuse and exploitation; and Kapit-Bisig Laban sa Kahirapan Comprehensive and Integrated Delivery of Social Services (KALAHI-CIDSS), a community driven development project that aims to empower communities by enhancing their participation in village – level governance where community member are involved in designing, implementing and managing development activities that reduce poverty will ensure that all approved BUB projects, categorized under its mandate will be implemented in accordance to the provisions stipulated in the DSWD Administrative Order DBM, DILG, DSWD and NAPC issued joint Memorandum Circular 02 Series of 2012 (JMC 03 S. 2012).

**WHEREAS**, Batangas City was chosen as beneficiary of this Sustainable Livelihood Program.

**WHEREAS**, there is need to grant authority to the City Mayor to enter into a Memorandum of Agreement between the Department of Social Welfare and Development (DSWD) and the City Government of Batangas.


