ENDORSING TO THE CALABARZON REGIONAL DEVELOPMENT COUNCIL, THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS AND THE TOLL REGULATORY BOARD THE CONSTRUCTION OF A FLY-OVER AT THE BALAGTAS ROTONDA IN BARANGAY BALAGTAS, BATANGAS CITY

WHEREAS, the opening of the STAR Tollway and the development of major thoroughfares within the City of Batangas connecting it to different parts of Southern Luzon brought with them heavy volume of traffic in the transportation of people and cargo;

WHEREAS, serious traffic congestions is most felt near the exit of the STAR Tollway to the Batangas Port Diversion Road, particularly at the rotonda in Barangay Balagtas, Batangas City;

WHEREAS, the construction of a fly-over in the said area remarkably ease this traffic problem;

NOW THEREFORE, be it resolved as it is hereby resolved, to endorse favorably to the CALABARZON Regional Development Council, the Department of Public Works and Highways and the Toll Regulatory Board the construction of a fly-over at the Balagtas Rotanda in Barangay Balagtas, Batangas City.

Referred to the Committee on Engineering and Public Works the above-titled endorsement of the City Mayor Eduardo B. Dimacuha on March 16, 2015.

The committee conducted a hearing on June 25, 2015 at 10:00 in the morning. Present during the hearing were Coun. Gerardo dela Roca - Chairman, Coun. Julian Villena, Coun. Alyssa Renee Cruz-Atienza, Coun. Aileen Grace A. Montalbo as members. Also present were Vice Mayor Francisco Emilio A. Berberabe, Jr., Coun. Glenn M. Aldover, Coun. Claudette Alday, Coun. Armando Lazarte, Coun. Hamilton Blanco, Coun. Kristine Balmes, Engineer Januario Godoy of City Planning and Development Office and Engineer Roy Marajas of City Engineer's Office.

During the hearing it was discussed that the best possible solution to the traffic congestion occurring at the Balagtas Rotonda especially during peak hours is the immediate construction of a fly-over over the Balagtas Rotonda linking the Batangas Port Diversion Road to the star tollway.

The committee deemed it appropriate to endorse to the CALABARZON Regional Development Council, the Department of Public Works and Highways and the Toll Regulatory Board the construction of a fly-over at the Balagtas Rotonda.
