**A RESOLUTION REQUESTING THE NATIONAL DISASTER RISK REDUCTION
AND MANAGEMENT COUNCIL (NDRRMC) FOR UPDATE ON THE STATUS OF
THE CONSTRUCTION/RESTORATION AND REHABILITATION OF THE
CALUMPANG BRIDGE ALONG DON JULIAN PASTOR MEMORIAL ROAD,
POBLACION 1, BATANGAS CITY**

WHEREAS, we, the members of the Sangguniang Panlungsod of Batangas City commends the immediate action taken by the NDRRMC to fund our request for the reconstruction and rehabilitation of the Calumpang Bridge through Resolution Nos. 186 and 187 S. 2014;

WHEREAS, according to the FY 2014 National Disaster Risk Reduction and Management Fund, Php 77,050,000.00 is allocated for the construction/restoration and rehabilitation of the Calumpang Bridge along Don Julian Pastor Memorial Road, Poblacion 1, Batangas City on September 24, 2014 with the DPWH-OSEC as the implementing agency;

WHEREAS, since the collapse of the Calumpang Bridge last July 16, 2014, we have yet seen any activities being done by the DPWH at the said bridge or have heard of any updates about it;

WHEREAS, Batangueños are facing the adverse effects of the collapse of the Calumpang Bridge such as heavy traffic, longer routes, higher prices and lack of available public transportation on a daily basis;


