**RESOLUTION NO. 7 S. 2015**

**RESOLUTION REQUESTING SECRETARY ROGELIO L. SINGSON OF THE  
DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO PRIORITIZE  
AND APPROPRIATE FUNDS FOR THE REPAIR AND RECONSTRUCTION FROM  
THE PORTION OF BARANGAY PAHARANG WEST TO BARANGAY SAN JOSE  
SICO ALONG THE BATANGAS-LOBO NATIONAL ROAD IN THE  
CITY OF BATANGAS**

**WHEREAS**, the aftermath of the Typhoon Glenda which resulted in the collapsed of the Calumpang Bridge cause the re-routing of trucks and other vehicles to utilize the Batangas-Lobo National Road;

**WHEREAS**, the Batangas - Lobo National Road have suffered much stress and destruction caused by the said re-routing;

**WHEREAS**, at present, this road is in need of urgent repair from Barangay Paharang West to Barangay San Jose Sico, otherwise, accidents may happen when the rainy season sets in causing great damage to the road;

**WHEREAS**, there is therefore a need to prioritize the fund allocation to repair the said portion of the road in order to restore the same for the convenience of the road users;

**NOW THEREFORE, BE IT RESOLVED**, as it is hereby resolved by the Sangguniang Panlungsod of Batangas City, to request the Department of Public Works and Highways Secretary Rogelio L. Singson to prioritize the repair of the portion from Barangay Paharang West to Barangay San Jose Sico along the Batangas-Lobo National Road in the City of Batangas and to appropriate funds thereof.


