RESOLUTION NO. 100 S. 2016

**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET FOR
CALENDAR YEAR 2016 OF DIFFERENT BARANGAYS OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of each of the Barangay Supplemental Budgets for Calendar Year 2016 submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the following Supplemental Barangay Budgets for Calendar Year 2016, to wit:

1. Cumba	P 805,050.41
2. Simlong	P 10,446,183.88
3. Sta. Clara	P 5,214,768.04
4. Talahib Pandayan	P 1,140,469.47

The budget documents shall form part of the authorized barangay budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the barangay officials.

These barangay budgets are therefore considered operative and effective as of January 1, 2016 in accordance with Section 332 of R.A. 7160.


