SUBJECT : Request of the City Civil Registrar for confirmation of

the setting up of a Trust Fund for the fees collected from the implementation of RA 9048 as amended by RA 10172

Referred to the Committee on Ways and Means is the request of the City Civil Registrar for the passage of a resolution confirming the setting up of a Trust Fund for the fees collected from the implementation of RA 9048 as amended by RA 10172, also known as the Clerical Error Law.

The material provision of law used as basis by the Civil Registrar for her request is as follows:

## OCRG ADMINISTRATIVE ORDER NO. 1 S. 2001 (Rules and Regulations Governing the Implementation of RA 9048)

Rule 18 - Authority to collect filing and other fees - The C/MR or the D/CR is hereby authorized to collect from every petitioner a filing fee in the amount of One Thousand Pesos (P1,000.00) for the correction of clerical or typographical error, and Three Thousand Pesos (P3,000.00) for change of first name or nickname. An indigent petitioner as defined under Rule 2.7 shall be exempt from the payment of said fee.

The local legislative body shall ratify the fees herein prescribed upon effectivity of this order. Prior to ratification by the local legislative body, all fees collected in connection with this order shall go to the LCRO trust fund. Provided, however that the fees prescribed herein shall be uniform in all cities and municipalities in the country, and in all Philippine consulates.

Relative to the subject is Ordinance No. 19 S. 2008 also known as the Batangas City Revenue Code of 2009 which provided:

Section 99. Civil Registry Fees. - The following fees shall be collected for services rendered by the Civil Registrar Office.

5. Fees and charges for filing petition for change of first name/correction of clerical error as mandated under RA No. 9048 and its IRR

A. Filing Fee

(a) Petition for Change of first name

P 3,000.00

(b) Petition for correction clerical error

P 1,000.00

B. Service Fees

) Migrant Petition for Change of first name P 1,000.00

(b) Migrant Petition for correction of clerical

P 500.00

The foregoing concludes that the Sangguniang Panlungsod has already ratified the fees prescribed under OCRG A.O. No. 1 S. 2001 thru the Batangas City Revenue Code of 2009 for the implementation of RA 9048 as amended by RA 10172. Therefore, the holding of such amounts collected from RA 9048/RA 10172 in a Trust Fund is no longer founded on the mandate of its implementing rules but on the sound discretion of the Office of the City Civil Registrar and authority of the Local Finance Committee. The City Civil Registrar submitted a copy of Subsidiary Ledger (As of December 31, 2015) evidencing the fact that the amounts collected in connection with RA 9048/RA 10172 have already been set up from General Fund to a Trust Fund.

What is left of the Council to resolve is the confirmation of the setting up of the Trust Fund for the collections of the City Civil Registrar from the implementation of RA 9048/RA 10172. The confirmation is now only ministerial since the Local Finance Committee has already authorized the transfer of the amounts from the General Fund to the Trust Fund already set up for the purpose. The resolution requested by the City Civil Registrar Office is for compliance of documentary requirement for accounting and auditing purposes.

#### RECOMMENDATION:

- 1. To approve the attached resolution confirming the setting up of a Trust Fund for the Fees Collected from the Implementation of RA 9048/RA 10172.
- 2. To adopt this Committee Report.
