WHEREAS, the FGEN LNG Corporation applies for Zoning/Locational Clearance for LNG Terminal-Access Road and Site Development;

WHEREAS, the proposed project is classifies as a Heavy Industrial Project which should be located in the Heavy Industrial Zone;

WHEREAS, Barangay Sta. Clara and Bolbok, Batangas City are component of the Heavy Industrial Zone per the Batangas City Land Use and Zoning Ordinance;

WHEREAS, the project proponent has complied with all the requirements for the approval of its application;

COMMITTEE REPORT

FROM : The Committee on Environment, Urban Development,

Land Use and Zoning

SUBJECT : Application for the Land Use Reclassification of the

project site for the proposed Batangas Liquefied Natural Gas (BLNG) Receiving and Regasification Terminal to be located in Barangays Bolbok and Sta.

Clara, Batangas City

Referred to the Committee is the Application of the First Gen Corporation for the land use reclassification of their property located in Barangays Bolbok and Sta. Clara, Batangas City for its proposed liquefied natural gas receiving and regasification terminal.

The committee held a hearing on June 10, 2015. The hearing was attended by the Vice Mayor and the members of the Sangguniang Panlungsod, by the representatives of the First Gen Corporation, namely: Danby Garcia, Omar del Rosario, Bernie Matibag, Ranchi Noel Resetosa and Ramon J. Araneta, Assistant City Assessor Arturo Fajilan, CPDO representatives Roselyn Guico and Delia Licarte and City Engineer Representative Melinda Aclan. Residents of Barangays Bolbok and Sta. Clara were likewise in attendance.

FINDINGS:

The application seeks approval of reclassification of land use from Port Zone to Heavy Industrial Zone for the property of First Gen Corporation located in Barangays Bolbok and Sta. Clara, Batangas City. The property is to be used for the proposed Batangas Liquefied Natural Gas Receiving and Regasification Terminal project of the First Gen The total land area of the subject property is Corporation. approximately 132,880.40 square meters. The current classification of the site is Port Zone. The proposed project is a heavy industrial project which requires a zoning classification of Heavy Industrial Zone. It is adjacent to the designated Heavy Industrial Zone where the existing and operational two (2) combined cycle natural gas power plants are located and two (2) other natural gas power plants are presently under construction, approximately 50 meters away from the shoreline of Batangas Bay, 300 meters from the Batangas Port facilities and container terminal. The property is outside the Batangas Port Zone. The affected barangays, Sta. Clara and Bolbok endorsed the project through separate and respective Barangay Council Resolution.

RECOMMENDATIONS:

The Committee recommends the following:

- The approval of the application for land use reclassification of the subject property of First Gen Corporation from Port Zone to Heavy Industrial Zone;
- To adopt the recommendations stated in the evaluation report of the City Planning and Development Office which is hereto annexed and made integral part of this committee report.
- To approve the attached ordinance exempting it from the three reading rule.
