COMMENT / RECOMMENDATIONS:

On February 9, 2016 the Sangguniang Panlungsod referred to the Committee on Appropriations for study, comment and recommendation the letter of the Honorable City Mayor dated February 3, 2016, the proposed Supplemental Budget No. 1 of the City Government of Batangas for Calendar Year 2016 amounting to P 452,570,919.50 for approval and a passage of a resolution authorizing the City Mayor to charge the cost of bidded city projects from the 650 million stand-by term loan agreement and to sign any document in relation thereto.

A hearing was conducted on February 10, 2016 attended by the Chairman and members of the committee and other members of the Sangguniang Panlungsod. Also present were Ms. Aster P. Marasigan of City Accountant Office, Engr. Sonny Godoy of CPDO, Ms. Elizabeth Q. Delos Reyes of City Budget Office, Engr. Corazon C. Lacorte, Mr. Jose Gallardo Palas and Mr. Reynato Marajas of City Engineers Office, Atty. Teddy Deguito of City Legal Office and Ms Estelita Lacsamana of OCVAS.

The chairman of the Committee on Appropriations briefly made on overview of the documents attached to the proposed Supplemental Budget No. 1 of the City of Batangas.

As stated in the budget documents, the sources of funds for the supplemental budget comes from the Surplus – General fund Proper (P 437,701,771.40), General Fund- Colegio ng Lungsod ng Batangas (CLB) (P 14,246,868.92) and 20% Development Fund (P 622,279.18). Hence, the total amount of savings available for appropriation is Four Hundred Fifty Two Million Five Hundred Seventy Thousand Nine Hundred Nineteen and Fifty Centavos (P 452,570,919.50).

The statement of funding sources and the different savings were certified correct by the Assistant City Accountant – OIC.
