“On motion of Councilor Cruz-Atienza seconded by Councilors Villena and Lazarte, the following Resolution was Adopted:

RESOLUTION NO. 59 S. 2016

RESOLUTION AUTHORIZING THE CITY MAYOR TO CHARGE THE COST OF THE ROAD PROJECTS TO THE SUPPLEMENTAL BUDGET FOR CALENDAR YEAR 2016 INSTEAD OF CHARGING THEM TO THE PHP 650 MILLION LAND BANK LOAN FACILITY

WHEREAS, the City Government was granted by the Land Bank of the Philippines a standby term loan agreement in the amount of Php650M to fund the former’s various infrastructure project;

WHEREAS, before the proceeds of the loan can be used and availed of by the City of Batangas, for the construction, repair and rehabilitation of various barangay and city roads which are in the list hereto attached, it is required that the Sangguniang Panlungsod make a resolution giving authority to the City Mayor to charge them from the loan and submit such authority to the Land Bank of the Philippines;

WHEREAS, up to the present time, it appears that the Sangguniang Panlungsod has not given such authority to the City Mayor to avail and use the proceeds of the loan for such purpose;

WHEREAS, on February 3, 2016, the Sangguniang Panlungsod received a letter request of even date from the City Mayor asking the Sangguniang Panlungsod to enact a resolution authorizing the City Mayor to avail and use the fund contained in the Supplemental Budget No. 1 S. 2016 instead and in lieu of the proceeds of the Php650M term loan from the Land Bank of the Philippines for the construction, repair and rehabilitation of various city and barangay roads contained in the hereto attached list;

WHEREAS, the Sangguniang Panlungsod does not find any legal impediment in granting the letter request of the City Mayor;

NOW THEREFORE, be it resolved as it is hereby resolved to grant the City Mayor the requested authority to use the funds contained in the Supplemental Budget No. 1 S. 2016 for the construction, repair and rehabilitation of the various barangay and city roads contained in the hereto attached list instead of and in lieu of the proceeds of the Php650M term loan granted by the Land Bank of the Philippines.




