**WHEREAS**, according to Rule 6 Section 12 of the Republic Act 10121 “An Act Strengthening the Philippines Disaster Risk Reduction and Management System Providing for the National Disaster Risk Reduction and Management Plan, Appropriating Funds Therefor and for Other Purposes”, the City Disaster Risk Reduction and Management Council is mandated to formulate and implement a comprehensive and integrated Disaster Risk Reduction and Management Plan;

**WHEREAS**, it has been drafted in accordance with the national, regional and provincial framework, and policies on disaster risk reduction in close coordination with the City Development Council;

**WHEREAS**, the City Disaster Risk Reduction and Management Council, gathered data, conducted meetings and workshops, conducted the Climate and Disaster Risk Assessment and consolidated the data to draft the Disaster Risk Reduction and Management Plan for the City of Batangas;

**WHEREAS**, the plan was presented to the City Disaster Risk Reduction and Management Council on December 13, 2016 and a second review was facilitated for finalization and approval of the Disaster Risk Reduction and Management Plan on February 28, 2017;



2. The approval of the required Resolution hereto attached.


