**RESOLVED**, to refer to the Committee on Laws, Rules and Regulations for its study, comments and recommendations the following:

1. Letter from the Honorable City Mayor, Beverley Rose A. Dimacuha requesting for a passage of a resolution granting the Mayor Authority to open an account with the Development Bank of the Philippines for the city’s 20% (trust fund) and SEF.
2. Letter from the Honorable City Mayor, Beverley Rose A. Dimacuha requesting for a passage of a resolution naming the existing accredited barangay health stations into Batangas City Government/San Isidro Health Center and Birthing Facility and Batangas City Government/Ilijan Health Center and Birthing Facility.
3. Letter from the Honorable City Mayor, Beverley Rose A. Dimacuha requesting for a passage of a resolution authorizing the City Mayor to enter into a Memorandum of Agreement with the DSWD-Field Office IV-A, regarding the implementation of programs and services for senior citizens specifically the Social Pension for Indigent Senior Citizens.




