

Subject: Barangay Ordinance no 1 s. 2017 of Barangay Talumpok Kanluran, Lungsod ng Batangas entitled "Isang ordinansa na nagpapataw ng mga buwis, singil at mga butaw sa mga tindahan; barangay clearance at sertipikasyon ukol sa iba pang layunin"

COMMENTS/RECOMMENDATIONS:

Section 152 of the local government code of 1991 and article 240 of the IRR grants the power of the barangay to impose taxes, fees and levies within the territorial jurisdiction of the barangay.

The Committee on Laws, rules and regulations and the Committee on Barangay Affairs find that the subject ordinance is in accordance with law and for the welfare of its constituents;


