WHEREAS, to serve its intention, the Batangas City Government authorize the Honorable City Mayor, Beverley Rose A. Dimacuha to open the said account.

NOW THEREFORE, be it resolved, as it hereby resolves, to authorize the City Mayor to open an account with the Development Bank of the Philippines.





SUBJECT : Letter from the City Mayor, Beverley Rose A. Dimacuha requesting for a passage of a resolution granting the Mayor authority to open an account with Development Bank of the Philippines for the City's Trust Fund, 20% Development Fund, and Special Education Fund (SEF).

COMMENTS/ RECOMMENDATION:

Referred to the Committee on Laws, Rules and Regulations is the above request for study, comment and recommendation.

2. The approval of the required Resolution hereto attached.


