

APPROVED UNANIMOUSLY by the Sangguniang Panlungsod of Batangas City this 14th day of September 2017.”



SUBMITTED BY : THE COMMITTEE ON LAWS, RULES AND REGULATIONS

SUBJECT: Letter from the City Vice Mayor Emilio Francisco A. Berberabe, Jr., requesting for the abolition and creation of certain positions in the Office of the Sangguniang Panlungsod.

COMMENTS / RECOMMENDATIONS:

Referred to the Committee on Laws, Rules and Regulations was the above letter for study, comments and recommendations.

A hearing was conducted on August 23, 2017 by the Committee attended by the Acting Chairman and its members and with the presence of other members of the Sangguniang Panlungsod. Also present were Ms. Aurea R. Castillo from the Office of Human Resource Department and Mr. Raymond Joseph Yumol from the office of Sangguniang Panlungsod.

On August 7, 2017, the Honorable City Vice Mayor requested for the abolition and creation of corresponding positions in the Office of the Sangguniang Panlungsod to wit:

Office of the Sangguniang Panlungsod:

Abolition:

One (1) Local Legislative Staff Officer V (SP-61/SG-22)

Creation:

Two (2) Administrative Aide IV (SG-4)

Two (2) Administrative Aide I

The source of funds amounting to P 868,530.00 comes from the position of Local Legislative Staff Officer V to be abolished and the said creations of two (2) Admin Aide IV and two (2) Admin Aide I have funds requirement amounting to P 842,248.00.

As per computation made by the Office of the City Budget Officer, the proposed creation of positions for the Office of the Sangguniang Panlungsod for Calendar Year 2017 does not violate the forty-five percent (45%) Personal Services limitation cited in Section 325 of Republic Act No. 7160 also known as the Local Government Code of 1991.

Considering the justifications stated by the Honorable City Mayor in his request for the abolition and creation of position, and there being no law or circular violated, the Committee hereby recommends:

- (a) the adoption of the Committee Report
- (b) approval of the resolution hereto attached
