#### **RESOLUTION NO. 280 S. 2017**

## A RESOLUTION APPROVING THE ACCREDITATION OF GUARDIANS PHILIPPINES ANTI-CRIME ORGANIZATION INCORPORATED

WHEREAS, presented before the Sangguniang Panlungsod were papers of Guardians Philippines Anti-Crime Organization Incorporated for Accreditation purposes;

WHEREAS, in adherence to the Local Government Code of 1991 as reiterated below the following provisions were elucidated among the representatives of Guardians Philippines Anti-Crime Organization Incorporated during the committee hearing held on September 6, 2017 at the Sangguniang Panlungsod Session Hall that were attended by the members of the said committee and other members of the Council.

- 1. Chapter 4. Relations with People's and Non-governmental Organizations.
  - 1.1. Section 34. Role of People's and Non-governmental Organizations. Local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy.
  - 1.2. Section 35. Linkages with People's and Non-governmental Organizations.

     Local government units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.

### A RESOLUTION APPROVING THE ACCREDITATION OF GUARDIANS PHILIPPINES ANTI-CRIME ORGANIZATION INCORPORATED

1.3. Section 36. Assistance to People's and Non-governmental Organization. – A local government unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise for economic, socially-oriented, environmental or cultural projects to be implemented within its territorial jurisdiction.

WHEREAS, the Committee on Accreditation of the Sangguniang Panlungsod has scrutinized the papers of Guardians Philippines Anti-Crime Organization in order to find out whether this NGO is qualified for accreditation and membership in the Local Special Bodies.

WHEREAS, the Sangguniang Panlungsod thru the Committee on Accreditation has approved the accreditation of Guardians Philippines Anti-Crime Organization as accredited NGO in the Sangguniang Panlungsod, after having found to have complied with all necessary requirements for this purpose, to wit:

NOW THEREFORE, BE IT RESOLVED BY THE SANGGUNIANG PANLUNGSOD IN SESSION ASSEMBLED TO APPROVE, AS IT IS HEREBY APPROVED, the Application for Accreditation of Guardians Philippines Anti-Crime Organization in the City of Batangas.

**RESOLVED FURTHER**, that all documents attached thereto be made integral parts of this resolution and that copies of this resolution be furnished the Guardians Philippines Anti-Crime Organization for their guidance and information.

**SUBJECT** 

Application for Accreditation of Guardians Philippines Anti-

Crime Organization Incorporated

The Committee called a Committee Hearing on September 6, 2017 for the purpose of evaluating the qualifications of the applicant for accreditation, and to reiterate the provisions of the Local Government Code and its implementing Rules and Regulations and to provide other clarificatory guidelines relative to the accreditation of people's organizations, non-governmental organizations and other organized groups, and in the selection of their representatives to the local special bodies. In attendance were: The representative of the applicant Guardians Philippines Anti-Crime Organization Incorporated (Cris De Guzman, Leonell Dalisay, Angel Castillejos, Rizalde Magnum Ramos, Teodoro Sarmiento, and Roberto Ricalde), the undersigned Chairman of the Committee on Accreditation, and other members of the Sangguniang Panlungsod — Councilors Oliver Macatangay, Julian Villena, Nelson J. Chavez and Karlos Buted. The members of the Committee — Councilors Serge Atienza, Armando Lazarte, Glenn Aldover and Gerry dela Roca had to attend equally important undertaking, hence they were not able to attend but expressed their conformity with the conduct of the hearing.

The committee hearing revolved around the accreditation of people's organization, nongovernmental organizations and similar aggrupations, which focused on the coverage, purpose, accreditation process and requirements and other related guidelines. The Committee finds that the applicant substantially complied with the requirements of the law for accreditation.
