**RESOLUTION ENDORSING THE REQUEST OF THE HONORABLE CITY MAYOR  
BEVERLEY ROSE A. DIMACUHA TO THE HONORABLE SECRETARY BENJAMIN  
E. DIOKNO OF THE DEPARTMENT OF BUDGET AND MANAGEMENT FOR A  
FINANCIAL GRANT AMOUNTING TO FIFTY MILLION PESOS  
(PHP 50,000,000.00) FOR THE ROAD REHABILITATION/CONSTRUCTION  
AT BARANGAY STA. CLARA, BATANGAS CITY**

**WHEREAS**, the Batangas International Port located in Barangay Sta. Clara, Batangas City has been identified as an alternate/complementary seaport of the Port of Manila;

**WHEREAS**, the seaport has become a major trading port outside Metro Manila, as well as passenger terminals boosting the tourism industry in the CALABARZON region;

**WHEREAS**, to sustain progress in the province and the region as well, there is a need to rehabilitate the road network in Barangay Sta. Clara, Batangas City;

**WHEREAS**, the road rehabilitation/construction project will effectively contribute to the full utilization of the Batangas International Port;

**WHEREAS**, the City Government of Batangas cannot defray the entire construction requirements of the road rehabilitation/construction project;
