**A RESOLUTION EXPRESSING SUPPORT FOR THE PASSAGE INTO LAW OF  
HOUSE BILL NO. 6124 AUTHORED BY HONORABLE MARIO VITTORIO  
“MARVEY” MARIÑO, REPRESENTATIVE, 5<sup>TH</sup> DISTRICT OF BATANGAS  
ENTITLED: “AN ACT DECLARING JULY 23 OF EVERY YEAR A SPECIAL NON-  
WORKING HOLIDAY IN THE CITY OF BATANGAS IN COMMEMORATION OF  
ITS FOUNDATION DAY TO BE KNOWN AS BATANGAS CITY FOUNDATION DAY”**

**WHEREAS**, pursuant to Republic Act No. 5495, Lungsod ng Batangas was formally declared as a City on July 23, 1969;

**WHEREAS**, since becoming a City on July 23, 1969, Batangas City has emerged as the economic focal point of trading, commercial and industrial activities in Southern Luzon;

**WHEREAS**, July 23 is considered significant in the history of Batangas City;

**WHEREAS**, to fully commemorate the significance of July 23 there is a need to declare the said date as a special non-working holiday in the entire city;

**WHEREAS**, the Office of the President of the Philippines issued on June 20, 2013 Proclamation No. 609 declaring July 23, 2013 as a special non-working day in Batangas City;

MARINO, Representative, Fifth District of Batangas, entitled: "An Act Declaring July 23 of Every Year A Special Non-Working Holiday in the City of Batangas to be known as Batangas City Foundation Day".


