**WHEREAS**, on August 16, 2017, the Regional Director of the Department of Social Welfare and Development Field Office IV-A sent a letter to the Honorable City Mayor thru the City Social Welfare and Development Officer, regarding the implementation of Cash for World(CFW) projects and activities under the Risk Resiliency Program for Climate Change and Adaptation and Mitigation (CCAM);

**WHEREAS**, on September 15, 2017, the City Social Welfare and Development Officer requested the City Mayor through a letter, for the endorsement of the Memorandum of Agreement and Specific Implementation Agreement with the DSWD Region IV-A, which allocates programs for Batangas City;

**WHEREAS**, on September 19, 2017, the Honorable City Mayor endorsed to the Sangguniang Panlungsod the request of the CSWDO Head for the passage of a resolution authorizing the City Mayor to enter into a Memorandum of Agreement and Specific Implementation Agreement with the DSWD Region IV-A for the implementation of social protection programs that will address the needs of the poor, empower citizens and promote inclusive growth in the City.
