REFERRING TO THE JOINT COMMITTEES ON LAWS, RULES AND REGULATIONS, ENVIRONMENT, URBAN DEVELOPMENT, LAND USE AND ZONING AND INFORMAL SETTLERS THE PROPOSED ORDINANCE MANDATING BALANCED HOUSING DEVELOPMENT IN THE CITY OF BATANGAS BY REQUIRING APPLICANTS FOR PRELIMINARY APPROVAL FOR LOCATIONAL CLEARANCE (PALC) AND DEVELOPMENT PERMIT (DP) FOR RESIDENTIAL SUBDIVISION PROJECTS TO PUT UP AND ESTABLISH THE SOCIALIZED HOUSING COUNTERPART AS REQUIRED UNDER SECTION 18, REPUBLIC ACT NO. 7279 WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF BATANGAS


