





**COMMITTEE REPORT**

SUBMITTED BY : THE COMMITTEE ON APPROPRIATIONS

SUBJECT : Letter from the Honorable City Mayor, Beverley Rose A. Dimacuha endorsing the City Disaster Risk Reduction Management Trusts Plan and Program 2017

COMMENTS/RECOMMENDATION:

Referred on the Committee on Appropriations is the above request for study, comments and recommendation.

A hearing was conducted on October 26, 2017 attended by the Chairman and members of the committee and other members of the Sangguniang Panlungsod. Also present were Mr. Rodrigo D. Dela Roca from the Office of the City Disaster Reduction Management, Ms. Aster P. Marasigan from the Office of the Treasurer and Mr. Federico Chavez from the Office of the City Accountant.

Section 12, Letter C (7) of R.A. 10121 ("Philippine Disaster Risk Reduction and Management Act of 2010") and Rule 6, Section 4 (8) of the Implementing Rules and Regulations of R.A. 10121, provide that the CDRRM shall "Prepare and submit to the local sanggunian through the LDRRMC and the LDC the annual LDRRMO Plan and Budget, the proposed programming of the LDRRMF, other dedicated disaster risk reduction and management resources, and other regular funding sources and budgetary support of the LDRRMO". What is required by the aforementioned law and its IRR is merely the submission of the annual LDRRMO Plan and Budget to the Sanggunian. Hence, the CDRRMO has already complied with the mandates of R.A. 10121.

Finding the CDRRMO Investment Plan in accordance with law and responsive to the needs of Batangas City in terms of disaster risk reduction / protection, the Committee recommends:

1. The adoption of this Committee Report;
2. The approval of the required Resolution hereto attached.
