RESOLUTION NO. 361 S. 2017

**GRANTING THE CITY MAYOR AUTHORITY TO GRANT INCENTIVE
BONUS (FRINGE BENEFITS) TO ALL OFFICIALS AND EMPLOYEES
OF THE CITY GOVERNMENT OF BATANGAS**

WHEREAS, the Local Chief Executive has been very explicit in its thrusts towards improving the lives of its people;

WHEREAS, fringe benefits is the administration’s manner of recognizing and appreciating the remarkable effort of all officials and employees of the City Government in contribution to the excellent performance of the City Government towards the attainment of the Seal of Good Local Governance and other remarkable accomplishments;

WHEREAS, the monetary reward for remarkable performance will indeed boost the morale of employees, especially this Christmas season, amidst the spiraling prices of commodities, educational expenses of their children;


NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to grant the City Mayor authority to grant incentive bonus (Fringe Benefits) to all officials and employees of the City Government of Batangas amounting to P15,000.00 for permanent employees (aside from the regular 13th month pay and cash gift) and P2,000.00 for DepEd Public School Teachers and Personnel in the Division of Batangas City chargeable against the savings of the city government subject to the usual accounting and auditing rules and regulations.

UNANIMOUSLY APPROVED.”


