**RESOLUTION GRANTING THE HONORABLE CITY MAYOR, BEVERLEY ROSE
A. DIMACUHA THE AUTHORITY TO ENTER INTO A CONTRACT TO EXTEND
THE 2017 SECURITY SERVICES CONTRACT TO WORLD CUP SECURITY
SERVICES INC., FOR A PERIOD OF THREE (3) MONTHS OR FROM JANUARY 1,
2018 AND UNTIL MARCH 31, 2018**

WHEREAS, under the General Welfare Act of the Local Government Code, the City Government is tasked to provide Security Services within and about Batangas City;

WHEREAS, the contract for Security Services has a duration of under December 31, 2017;

WHEREAS, there is a need to extend the existing 2017 Security Services Contract to WORLD CUP SECURITY SERVICES INC., for at least three (3) months as the Public Bidding for the new contract is yet to be conducted;

WHEREAS, contract extension will serve as an emergency measure to maintain status quo in the security operations specifically in guarding and protecting the City Government’s personnel, premises and properties from theft, pilferage, burglary, robbery, arson, vandalism, trespass and other criminal and unlawful acts;

WHEREAS, WORLD CUP SECURITY SERVICES INC., the current service provider, has not violated any of the provisions of the original contract;



RESOLVED FURTHER, that copies of this resolution be forwarded to the offices concerned for their information and reference.



SUBJECT : Letter from the City Mayor, Beverley Rose A. Dimacuha requesting for the passage of resolution granting the City Mayor the authority to enter into a contract to extend the 2017 Security Services Contract to WORLD CUP SECURITY SERVICES INC. for a period of three (3) months or from January 1, 2018 and until March 31, 2018.

COMMENTS/ RECOMMENDATION:

Referred to the Committee on Laws, Rules and Regulations is the above request for study, comment and recommendation.

A hearing was conducted on December 6, 2017 attended by the Chairman and members of the committee and other members of the Sangguniang Panlungsod. Also present were General Services Department Head Ms. Joyce Cantre, Mr. Wilson Petigo and Mr. Johnny Biton both from WORLD CUP SECURITY SERVICES INC.

The contract for security services has a duration of until December 31, 2017. There is a need to extend the existing 2017 Security Services Contract because it will serve as an emergency measure to maintain status quo in the security operations specifically in guarding and protecting the City Government's personnel, premises and properties from theft, pilferage, burglary, robbery, arson, vandalism, trespass and other criminal and unlawful acts.

WORLD CUP SECURITY SERVICES INC., which is the current service provider, has not violated any of the provisions of the original contract and this extension will not change or modify the terms and conditions of the original contract, except when changes or modifications will redound to the advantage of the government and no additional cost to the City Government.
