**RESOLUTION NO. 376 S. 2017**

**RESOLUTION GRANTING THE HONORABLE CITY MAYOR, BEVERLEY ROSE  
A. DIMACUHA, THE AUTHORITY TO ENTER INTO A CONTRACT TO EXTEND  
THE 2017 GARBAGE COLLECTION, HAULING AND DISPOSAL SERVICES AND  
THE OPERATION AND MANAGEMENT OF SANITARY LANDFILL CONTRACT  
TO METROWASTE SOLID WASTE MANAGEMENT CORPORATION FOR A  
PERIOD OF THREE (3) MONTHS OR FROM JANUARY 1, 2018 AND  
UNTIL MARCH 31, 2018**

**WHEREAS**, under the General Welfare Act of the Local Government Code, the City Government is tasked to provide garbage collection, hauling and disposal services and an operational Sanitary Landfill within and about Batangas City;

**WHEREAS**, the contract for garbage collection, hauling and disposal services and operation and management of Sanitary Landfill has a duration of until December 31, 2017;

**WHEREAS**, there is a need to extend the existing 2017 garbage collection, hauling and disposal services and operation and management of Sanitary Landfill contract of METROWASTE SOLID WASTE MANAGEMENT CORPORATION for at least three (3) months as the Public Bidding for the new contract is yet to be conducted;

**WHEREAS**, this extension will not change or modify the terms and conditions of the original contract, except when changes or modifications will redound to the advantage of the government and no additional cost to the City Government.

**NOW THEREFORE, be it resolved, as it hereby resolves**, by the Sangguniang Panlungsod in session assembled to grant authority to Honorable City Mayor, Beverley Rose A. Dimacuha to enter into a contract to extend the 2017 garbage collection, hauling and disposal services and the operation and management of Sanitary Landfill contract to METROWASTE SOLID WASTE MANAGEMENT CORPORATION for a period of three (3) months or from January 1,2018 and until March 31, 2018;


**RESOLVED FURTHER**, that copies of this resolution be forwarded to the offices concerned for their information and reference.



SUBJECT : Letter from the City Mayor, Beverley Rose A. Dimacuha requesting for the passage of resolution granting the City Mayor the authority to enter into a contract to extend the 2017 Garbage Collection, Hauling and Disposal Services and the Operation and Management of Sanitary Landfill contract to METROWASTE SOLID WASTE MANAGEMENT CORPORATION for a period of three (3) months or from January 1, 2018 and until March 31, 2018.

**COMMENTS/ RECOMMENDATION:**

Referred to the Committee on Laws, Rules and Regulations is the above request for study, comment and recommendation.

A hearing was conducted on December 6, 2017 attended by the Chairman and members of the committee and other members of the Sangguniang Panlungsod. Also present was General Services Department Head Ms. Joyce Cantre and Ms. Jea Ventura of METROWASTE SOLID WASTE MANAGEMENT CORPORATION.

The contract for garbage collection, hauling and disposal services and operation and management of Sanitary Landfill has a duration of until December 31, 2017.
