**RESOLUTION NO. 93 S. 2017**

**RESOLUTION AUTHORIZING THE INCUMBENT CITY MAYOR TO CHARGE THE COST OF THE ENUMERATED CITY PROJECTS ON THE P650 MILLION STAND-BY TERM LOAN AGREEMENT AND TO SIGN ANY DOCUMENT IN RELATION THERETO**

**WHEREAS**, the City of Batangas has an existing term loan facility in the amount of P650M as stand-by credit for various City Government Projects with the Land Bank of the Philippines;

**WHEREAS**, then City Mayor Eduardo B. Dimacuha requested for authority to charge the following projects on the P 650,000,000.00 term loan facility with the Land Bank of the Philippines, to wit:

1. Completion of Public Market Cost	P 110,000,000.00
2. Completion of Colegio ng Lungsod ng Batangas (CLB)	P 89,000,000.00
3. CLB Laboratory & Other Equipment	P 25,000,000.00
4. Improvement of Grandstand	P 55,000,000.00
5. Reconstruction of City Engineer's Office	<u>P 30,000,000.00</u>
	<b>P 309,000,000.00</b>

**WHEREAS**, the Sangguniang Panlungsod by Resolution No. 31 S. 2016 granted the request of then City Mayor Eduardo B. Dimacuha for such authority;

**WHEREAS**, before the Land Bank of the Philippines could release funds for the above stated projects, the administration of the City Mayor Eduardo B. Dimacuha was overtaken by the May 2016 election where the incumbent Mayor Beverley Rose A. Dimacuha was elected;

**WHEREAS**, the incumbent City Mayor has decided to restudy and remove from the list of the following items:

- (a) Colegio ng Lungsod ng Batangas Laboratory and other Equipment
- (b) Improvement of the Grandstand

**WHEREAS**, it becomes necessary that the incumbent City Mayor Beverley Rose A. Dimacuha be given a fresh mandate to use and avail of the aforesaid loan in relation to the following enumerated projects;


