

COMMITTEE REPORT

TO: HONORABLE VICE MAYOR AND SANGGUNIANG PANLUNGSOD MEMBERS

FROM: COMMITTEE OF THE WHOLE

SUBJECT: COMPLAINT FILED BY RONALDO FANTILANAN AGAINSTS BARANGAY CAPTAIN LORENZO GAMBOA AND KAGAWAD RICO ADARLO "SP BLG.02-17 FOR GRAVE MISCONDUCT, CONDUCT PREJUDICIAL TO THE BEST INTEREST OF UNBECOMING PUBLIC OFFICIAL AND "SP BLG. 03-17 FOR GRAVE MISCONDUCT, AND NEGLECT OF DUTY.

On January 24, 2018, the Committee of the Whole called the initial hearing of the above subject administrative case. Only the respondents appeared. Upon review of the records of the case, it was found out that the Notice of Initial Hearing was not properly served to the complainant, that since the complainant was not found in his given address, the personnel serving the notice had it received by a Barangay Administrative Aide (Clerk) at the Barangay Hall. The Committee Chairman decided, as a measure of prudence, to send a second Notice of Initial Hearing through Registered Mail by a courier service (LBC) setting the said hearing on January 31, 2018.

On January 27, 2018, the courier service stated that the addressee complainant cannot be located. Thus, the complainant did not appear again on January 31, 2018 in the scheduled hearing. The committee also took diligent efforts to inquire and locate the complainant but information received from residents in the area of the last given address of the complainant states that the latter is no longer staying in the said address and had moved out already.

During the hearing, the counsel for respondent moved for the dismissal of the case due to the apparent lack of interest of the complainant to pursue the case. All members of the Committee of the Whole who are present (Vice Mayor Dr. Emilio Francisco Berberabe Jr., Councilor Aileen Montalbo, Councilor Dr. Glenn M. Aldover, Councilor Oliver Macatangay, Councilor Armando Lazarte, Councilor Gerardo Dela Roca, Councilor Nestor Dimacuha, Councilor Nelson Chavez, Coun. Alyssa Renee Cruz-Atienza and Coun. Sergie Rex Atienza) voted to approve the motion.

Considering the foregoing, the Committee recommends:

1. The dismissal of the Administrative Cases No. 02-17 and 03-17 and the approval of the attached Resolution.
2. To inform the Office of the Ombudsman for Luzon of the action taken by the Sangguniang Panlungsod on the subject Administrative Cases.
3. To adopt this Committee Report.
