RESOLUTION NO. 139 S. 2019

**NAMING THE CALUMPANG RIVER THIRD BRIDGE THE EBD
BRIDGE OF PROGRESS**

WHEREAS, Section 13 of RA 7160 otherwise known as the Local Government Code of 1991 provides:

Section 13. Naming of Local Government Units and Public Places and Structures.

- (c) The Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction:

WHEREAS, Batangas City has become the progressive city that it is today undeniably through the outstanding governance of its leaders for the last three decades;

WHEREAS, among the trailblazers of progress that Batangas City now experiences is the program Eto Batangueño Disiplinado launched in 1990 covering a myriad of developmental thrusts of the then new administration;

WHEREAS, the visions of Eto Batangueno Disiplinado program have become a reality as Batangas City is now a prime city in the CALABARZON Region;

WHEREAS, the Calumpang River Third Bridge which spans Brgy. Kumintang Ibaba and Brgy. Gulod Labac over the historic Calumpang River is a fitting cap to the outstanding accomplishments of Eto Batangueno Disiplinado program;

WHEREAS, the Sangguniang Panlungsod deems it appropriate to dedicate the Batangas City Third Bridge in honor of the Eto Batangueno Disiplinado program which ushered progress to Batangas City, by naming the bridge "The EBD Bridge of Progress";

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to name the Calumpang River Third Bridge "The EBD Bridge of Progress";

RESOLVED FURTHER, that representations with the Philippine Historical Commission be made for the approval of the naming of the bridge as stated in the foregoing;

RESOLVED FURTHERMORE, that copies of this Resolution be furnished the Office of the President and the Office of the District Representative Batangas Fifth District in accordance with the requirements of the Local Government Code of 1991.


