**RESOLUTION NO. 13 S. 2019**

**REQUESTING THE DPWH TO INSTALL ROAD SAFETY SIGNAGES  
ALONG DIVERSION ROAD OF BATANGAS CITY**

**WHEREAS**, Section 16 of the Local Government Code of 1991 states that every Local Government Unit shall exercise powers xxx which are essential for the promotion of general welfare within their respective territorial jurisdiction, local government units shall ensure and support among other things, promote health and safety and maintain peace and order and preserve the comfort and convenience of the inhabitants;

**WHEREAS**, it is observed that Diversion Road has alarming number of vehicular accidents daily;

**WHEREAS**, it is important to alert drivers for their speed limit to prevent accidents in this particular highway;

**WHEREAS**, the Sangguniang Panlungsod aims to promote safety and convenience to both commuters and drivers;

**NOW THEREFORE**, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to request the Department of Public Works and Highways (DPWH) to install road safety signages along Diversion Road of Batangas City.


