SUBJECT

Matters regarding Rugby Boys

BACKGROUND

The issue regarding the involvement of "Rugby Boys" in an arson case at Rizal Avenue, as well as their association in various cases of harassment and other petty crimes in Batangas City was raised by Councilor Alyssa Renee A. Cruz during the Privilege Hour of the Regular Session last July 30, 2019. Because of this alarming issue, the attention of the Committee on Social Welfare was called and last August 23, 2019 at 1:00 PM, a Committee Hearing was held in the Sangguniang Panlungsod Session Hall. The committee hearing was attended by Barangay Officials from various Barangays of Batangas City, City Social Welfare Office headed by CSWDO Mrs. Mila M. Española, RSW, Philippine National Police headed by PLT Col. Sancho O. Celedio, City Defense and Security Services (DSS) Office represented by Mr. Bryan Ebora, City Mayor's Office represented by Mr. Manolo Perlada, and the Committee Members of the Committee on Social Welfare and Sangguniang Panlungsod Members including Vice Mayor Emilio Francisco A. Berberabe, Jr.

BRIEF DISCUSSIONS


During the committee hearing, various concerns were raised by the Committee Chairman and other members of the Sangguniang Panlungsod regarding the issues involving Rugby Boys which includes the following:

- 1. Reports of various minor crimes that involves Rugby boys including but not limited to, harassment, hold-up, and theft;
- 2. Loitering along major streets of Batangas City, obstructing business for various establishments and harassing pedestrians;
- 3. Possession of sharp and pointed objects, particularly knife and/or ice peak which terrorized the general public;
- 4. Participation in various acts of destruction of private properties;
- 5. Bullying incidents of innocent children;
- 6. Gathering in groups and forming gangs to collectively perform menacing acts, among others.

The discussion flow include testimonies of resource persons of their various acts of intervention to suppress and/or prevent the aforementioned problems as well as the many limitations they face in performing their duties brought about by the boundaries of existing Laws, Regulations, Ordinances and other similar issuances due to the fact that the involve parties are minors.

The following are the notable statements, comments and suggestions from different implementing agencies present at the committee hearing:

- 1. The Philippine National Police (PNP) represented by PLT. Col. Sancho Celedio reported that they are conducting regular round-up of the Rugby Boys, identified the existence of organized group behind some of the criminal acts, profiled their SOP and worked on disbanding and apprehending suspects. Due to the limitations of the law, they cannot detain minor offenders and was forced to release them instead to the care of other agencies like the CSWDO or VAWC Desk officials of Barangays where they reside. They observed that there is a need to put in place a strong working and preventive guidelines to support the campaign against the proliferation of Rugby Boys in the City. The PNP requested the various Barangays for their full cooperation and participation by being their eyes and ears in their respective Barangays, monitor the situation and report to the PNP if necessary. It was also suggested that there is a need to establish a rehabilitation facility away from the City to accommodate the children involved;
- 2. Because of the limitation of the Law, criminal charges cannot be given to the Rugby Boys. There is a suggestion to include or implement other measures to instill the gravity of the offense to the minor offenders aside from the prescribed punishment available to them (e.g. performing community service);
- 3. The inclusion of insisting parental responsibilities to the parents or legal guardians of the minor offenders should also be institutionalize in the local level;
- 4. Increasing the visibility of police and local law and order enforcers like DSS and Barangay Tanods in places identified as Rugby Boys gathering area or in areas where they are possibly present at certain times of day and/or night (e.g. Luma or Bagong Palengke, Mabini Plaza, Rizal Avenue, P. Burgos St. etc.);
- 5. There is a need to strengthen the existing local implementing law against the Rugby Boys particularly Ordinance No. 01 S. 2000 and update it to comply with the Batangas City Child Welfare Code of 2019, Anti-Violence Against Women and Their Children Act of 2004, and Juvenile Justice and Welfare Act of 2006;
- 6. To institutionalize the action of the Local Government and to provide humane and systematic procedure in handling cases of Children in Conflict with the Law, the City Social Welfare and Development Office (CSWDO) urges for the adoption of the Batangas City Comprehensive Local Juvenile Intervention Plan 2019-2021.

To address the issues mentioned during the discussions, the Executive Department stated that it will be included in the agenda of the Peace and Order Council as they convene to formulate the Peace and Order and Public Safety Plan for the year 2019-2022.

The importance of institutionalizing various efforts in the rehabilitation of the Rugby Boys and their parents to include comprehensive program for the Psychiatric guidance, health improvement, education and skill enhancement program was recognized to be very important and recommended to the Local Executive Department

The committee recognizes the importance of working hand-in-hand and urges the various agencies to work together in the effective and efficient implementation of the various existing laws that governs the handling of various cases involving Rugby Boys.
