RESOLUTION NO. 299 S. 2019

**A RESOLUTION URGING THE CITY SOCIAL WELFARE DEPARTMENT (CSWD)
OFFICE, THE PHILIPPINE NATIONAL POLICE (PNP)-BATANGAS CITY, CITY
DEFENSE AND SECURITY SERVICES (DSS) OFFICE AND ALL BARANGAY
OFFICIALS TO EFFECTIVELY AND EFFICIENTLY IMPLEMENT ORDINANCE
NO. 9, S. 2012 AND ORDINANCE NO. 01, S. 2000**

WHEREAS, the City recognizes the right of the children for utmost protection and assistance in accordance with the provisions of R.A. 9344 as amended by R.A. 10630 otherwise known as the Juvenile Justice and Welfare Act as stated in Chapter VII, Section 44 of “The Batangas City Child and Youth Welfare Code of 2019;

WHEREAS, Section 6 of Ordinance No. 9 S. 2012 states that, “The City Government of Batangas shall implement the Comprehensive City Juvenile Intervention Program (CJIP), through a collaborative undertaking between and among the Sangguniang Panlungsod, City Mayor community-based youth and school organization, NGO’s, and other concerned agencies, to address causes of offending, provide assistance to Children in Conflict with the Law (CICL) and alternative modes to avoid the child’s contact with the juvenile justice system;

WHEREAS, Ordinance No. 1, S. 2000 prohibits and penalized minors to sniff or consume glue, rugby, paint thinner, gasoline and other volatile substance producing hallucination sedateness, stimulation and the likes;
