RESOLUTION NO. 351 S. 2019

RESOLUTION REQUIRING ALL DENTAL PRACTITIONERS IN BATANGAS CITY TO STRICTLY COMPLY WITH THE REQUIREMENTS AND PROVISIONS OF REPUBLIC ACT 9484 OTHERWISE KNOWN AS "THE PHILIPPINE DENTAL ACT OF 2007"

WHEREAS, Section 16 of the Local Government Code of 1991 states that, "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public moral, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Batangas City recognizes the importance of dentists, dental hygienists and dental technologists in building a healthy and safe community; building awareness to ensure that the constituency have access to an effective oral health care services from competent productive, morally-upright, and well-rounded practitioner whose standards of professional practice and service shall be excellent, qualitative, world-class and internationally recognized, globally competitive through regulatory measure, programs and activities that foster their continuing professional development;

RESOLUTION REQUIRING ALL DENTAL PRACTITIONERS IN BATANGAS CITY TO STRICTLY COMPLY WITH THE REQUIREMENTS AND PROVISIONS OF REPUBLIC ACT 9484 OTHERWISE KNOWN AS "THE PHILIPPINE DENTAL ACT OF 2007"

WHEREAS, there exist dental practitioners in Batangas City who does not qualify to provide dental services whose actions proves to be detrimental to public safety.

WHEREAS, Republic Act 9484, otherwise known as "The Philippine Dental Act of 2007" regulate the practice of dentistry, dental hygiene and dental technology in the Philippines:

WHEREAS, Article V, Section 34 of the aforementioned Act states that, "It shall be the duty of all constituted officers of the law of the national, provincial, city municipal or barangay level of the government, to enforce the provisions of this Act as well as the rules and regulations pertinent thereto and to prosecute any person violating the same. The Secretary of Justice shall act as the legal adviser of the Board and the Commission and shall render such legal assistance as may be necessary in carrying out the provisions of this Act";

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Panlungsod in session assembled to require all dental practitioners in Batangas City to strictly comply with the requirements and provisions of Republic Act 9484 otherwise known as "The Philippine Dental Act of 2007".

RESOLVED FURTHER, to furnish the Philippine Dental Association of Batangas City of this Resolution upon its approval for their information and strict compliance.
