WHEREAS, the City Mayor has requested for authority to avail the P81 million of the P650 million representing the remaining portion of the Omnibus term loan facility of the City Government of Batangas from Land Bank of the Philippines and the realignment/reprogramming of the previously approved allocation of Term Loan 13 in the amount of P16 million originally earmarked for the rehabilitation of Balete Barangay Road, with a total amount of P97 million to be utilized for the following projects, to wit:
