2. A Resolution Authorizing the City Mayor to enter into a Memorandum of Agreement with the Golden Gate Colleges for the establishment of Sitio Bagong Umaga located in Barangay Tinga Labac, Batangas City, as beneficiary of GGC’s Community Development and Social Orientation Program.
3. A Resolution Authorizing the City Mayor to sign a Compromise Agreement between Meralco and the City Government of Batangas.
