**RESOLUTION NO. 381 S. 2019**

**A RESOLUTION URGING THE STRICT IMPLEMENTATION OF VARIOUS  
TRAFFIC RULES AND REGULATIONS IN THE CITY OF BATANGAS**

**WHEREAS**, it has been noted that records of motorcycle accidents within the City of Batangas is on the rise with the most of these cases involving drivers violating the speed limit, drunk motorist, motorcycle riders without valid driver’s license and motorcycles without complete documents;

**WHEREAS**, there is a need to ensure that the City Government of Batangas shall impose and make every effort to institute measures to deal with this pressing concern pursuant to its powers and functions under the Local Government Code;

**WHEREAS**, for and in the interest and safety of the general public, the City of Batangas should ensure the strict implementation of the Transportation Code of Batangas City and other transportation and traffic laws or ordinances; that the streets and major thoroughfares of the City are free from law – violating motorists, vehicles which are not road – worthy; and to institute processes in support to the implementation of the laws in traffic as provided for under RA 4136 or the Land Transportation and Traffic Code, RA 8750 or the Seat Belts Use Act of 1999, RA 10666 or the Children’s Safety in Motorcycle Act of 2015 and RA 10054 or the Motorcycle Helmet Act of 2009.
