**WHEREAS**, the City Mayor, Beverley Rose A. Dimacuha requests for a resolution authorizing her to enter into a Memorandum of Agreement between the Environment Management Bureau-DENR and the City Government of Batangas for the establishment of a Material Recovery Facility;

**WHEREAS**, the request is deemed vital in the development and implementation of Local Solid Waste Management Plans and Programs;


