**UNANIMOUSLY APPROVED.”**



DECISION:







## DECISION

This is an Administrative Case of Serious Misconduct, Abuse of Authority & Immorality filed by Mr. Christian De Castro Villena of Brgy. Poblacion #5 against Brgy. Capt.
