COMMITTEE REPORT

TO : The Honorable Presiding Officer and
Members of the Sangguniang Panlungsod

FROM : Committee on Laws, Rules and Regulations

SUBJECT : Proposed Ordinance for the Safety of Children Aboard
Motorcycles Providing Penalties for Violation
Thereof and for Other Purposes

In the regular session on September 24, 2019, the subject Ordinance was approved on First Reading and referred to the Committee on Laws, Rules and Regulations. The Committee held a hearing on October 16, 2019 and in attendance were the Chairman and members of the Committee on Laws, Rules and Regulations, the Vice Mayor and all other members of the Sangguniang Panlungsod. Also present were CSWDO: Mila Española and Mr. Manolo Perlada of the City Mayor's Office.

The Committee finds that there is no legal impediment in passing the Ordinance, which according to Mrs. Española, is based on the national law (IR 10666) and which is required by the DILG to be implemented by the LGU. There are several suggested modification such as concerning the penalty of imprisonment and to consider graduated penalties for first, second, and third offenses.

The Committee thereby recommends:


1. The adoption of this Committee Report.
2. That the proposed ordinance be scheduled for Second Reading in the next Regular Session
