**GRANTING AUTHORITY TO THE CITY MAYOR BEVERLEY ROSE A.
DIMACUHA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH

WHEREAS, RA 9514 otherwise known as Revised Fire Code of the Philippines of 2008 provides public safety and promote economic development through the prevention and suppression of kinds of destructive fires and promote the professionalization of the fire service as a profession;

WHEREAS, RA 9485 or the Anti-Red Tape Act of 2007 was enacted to eliminate Red Tape and to simplify frontline service procedures, formulate service standards to observe in every transaction and make known these standards to the client;

WHEREAS, this Memorandum of Agreement prescribes the guidelines for the efficient assessment, collection and remittance of Fire Safety Inspection Fee (FSIF) by the City Treasurer’s Office on all business permits application/registration and renewal in Batangas City;


In the regular session of November 11, 2019, the letter was referred to the Committee on Laws, Rules and Regulations for study, comments and recommendations.
