**RESOLUTION URGING ALL INDUSTRIAL COMPANIES TO SUBMIT LIST

WHEREAS, the Local Government Code has empowered the City of Batangas to raise revenue;

WHEREAS, Section 171 of RA 7160 otherwise known as the Local Government Code of 1991 provides... “That the City Treasurer may, by himself or through any of his deputies be authorized to examine the books of accounts and pertinent records of businesses for the purpose of ascertaining, assessing and collecting the correct amount of the tax, fee or charge”;

NOW THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Panlungsod in session assembled to urge all industrial companies to submit the list of service providers like transportation and hauling services employed and engaged in extending service with them.
