RESOLVED, to refer to the Committee on Barangay Affairs the following Barangay Ordinances for its appropriate actions:

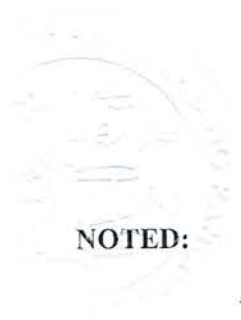


