#### RESOLUTION NO. 69 S. 2019

A RESOLUTION APPEALING AND SEEKING THE BENEVOLENCE OF HIS EXCELLENCY, PRESIDENT RODRIGO ROA DUTERTE ALONG WITH THE DEPARTMENT OF TRANSPORTATION AND LAND TRANSPORTATION AND REGULATORY BOARD TO EXTEND THE TIMELINE SET FORTH IN LTFRB MEMORANDUM CIRCULARS 2018-006 AND 2018-008 SETTING THE GUIDELINES FOR THE CONSOLIDATION OF FRANCHISES INTO A JURIDICAL ENTITY AS COOPERATIVES OR CORPORATIONS UNTIL MARCH 18, 2019

WHEREAS, the Sangguniang Panlungsod recognizes the persistence and determination of the Honorable Secretary Arthur Tugade of the Department of Transportation and Honorable Chairman Martin Delgra III of the Land Transportation and Regulatory Board in taking bold steps towards progress through the biggest transportational initiative of the Duterte administration in the transportation sector;

WHEREAS, under Land Transportation and Regulatory Board (LTFRB) Memorandum Circular 2018-008, individual operators are encouraged and required to consolidate into a juridical entity as Transport Cooperative or Corporation until March 18, 2019 to participate in the public utility vehicle (PUV) modernization program;

WHEREAS, after March 18, 2019 Land Transportation and Regulatory Board (LTFRB) shall consider the applications for the issuance of Certificate of Public Convenience (CPCs) filed by single juridical entities those are Transport Cooperatives and Corporations on the authorized route of the existing individual franchise holders;

WHEREAS, in the course of the upcoming March 18, 2019, the Sangguniang Panlungsod of Batangas City through the Committee on Cooperatives and Committee on Transportation and the City Government through the Office of the City Veterinary and Agricultural Services Cooperative Division and the Transportation Development Regulatory Office (TDRO) had been the supplemental avenue by the National Government in mitigating false notions and enlightening public utility jeepney associations towards the advantages of the aforesaid program not just to the riding public but to the individual operators;

WHEREAS, amid the ongoing efforts of the Local Government to assist and the fact that there were public utility jeepney associations who are already in coordination and partnership with a transport cooperative, there are still a number of operators who are unequipped with proper information towards the program and the consolidation of franchise holders in which a mass transportation summit will be of great help with the presence of LTFRB resource person/s in order to avoid aggravating perceptions and situations of which may be inimical to the part of not just the riding public but to the individual operators as well;

WHEREAS, with the foregoing, the Sangguniang Panlungsod would like to appeal and request for the extension of the timeline set forth as March 18, 2019 to be extended for at least three (3) months for not just those individual franchise holders to have ample time to consolidate but for those number of franchise holders who are willing or consolidating and in coordination with single juridical entities or cooperatives and in order to have sufficient time to raise necessary required funds and other requirements in compliance for such and provide for deeper understanding to the program for other operators;

NOW THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Panlungsod of Batangas, by virtue of the powers vested in it by law, in session assembled, to appeal and seek the benevolence of His Excellency, President Rodrigo Roa Duterte along with the Department of Transportation and Land Transportation and Regulatory Board to extend the timeline set forth in LTFRB Memorandum Circulars 2018-006 and 2018-008 setting the guidelines for the consolidation of franchises into a juridical entity as cooperatives or corporations until March 18, 2019.

**RESOLVED FURTHER**, that copies of this resolution be forwarded to His Excellency President Rodrigo Roa Duterte, Hon. Secretary Arthur Tugade of the Department of Transportation, Hon. Chairman Martin Delgra III of the Land Transportation and Regulatory Board and Hon. Congressman Mario Vittorio "Marvey" Mariño of the 5<sup>th</sup> District of Batangas.
