

COMMITTEE REPORT

TO : The Honorable

SUBJECT : Barangay Ordinance Nos. 1 and 2, Series of 2019 of  
Soro-soro Ilaya, Batangas City

Referred to the Committee on Barangay Affairs are the following ordinances:

1. Barangay Ordinance No. 1 S. 2019 of Barangay Soro-soro Ilaya, Batangas City "Ordinansa sa Pagpapataw ng Singil sa mga Commercial at Residential na Establishment na matatagpuan sa Barangay Soro-soro Ilaya, Lungsod ng Batangas".
2. Barangay Ordinance No. 2 S. 2019 of Barangay Soro-soro Ilaya, Batangas City "Ordinansa sa Pagpapatala ng Kaukulang Datus at Impormasyon sa lahat ng may mga unit sa Mercedes Homes Subdivision, Barangay Soro-soro Ilaya, Lungsod ng Batangas, Maging ang mga nangungupahan (rent) sa nasasakupang ng bawat sityo".

The Committee met with the representatives of the aforementioned barangay and discussed its form and contents of their ordinances.

**FINDINGS:**

1. Barangay Ordinance No. 1 S. 2019 of Barangay Soro-soro Ilaya, Batangas City "Ordinansa sa Pagpapataw ng Singil sa mga Commercial at Residential na Establishment na matatagpuan sa Barangay Soro-soro Ilaya, Lungsod ng Batangas".

Local Government Units, including barangay, are granted the power to create their own sources of revenues and collect from the same. Particularly, the Local Government Code provides:

Section 129, Power to Create Sources of Revenue. - Each local government unit shall exercise its power to create its own sources of revenue and levy taxes, fees and charges subject to the provisions herein, consistent with the basic policy of local autonomy. Such taxes, fees and charges shall accrue exclusively to the local government units."

Likewise, Section 152 (c) of the same Code provides:

"Section 152 (c) Barangay Clearance - No city or municipality may issue any license or permit or any business or activity unless a clearance is first obtained from the barangay where such business or activity is located or conducted".

This is in line with the principles of local autonomy which is the spirit of the Local Government Code. Barangay Soro-soro Ilaya, give effect to the provision of law by tapping their own resources to contribute to barangay development.

These barangay ordinances are within the powers of the barangay to enact and are in accordance with the requirements of law.

2. Barangay Ordinance No. 2 S. 2019 of Barangay Soro-soro Ilaya, Batangas City "Ordinansa sa Pagpapatala ng Kaukulang Datus at Impormasyon sa lahat ng may mga unit sa Mercedes Homes Subdivision, Barangay Soro-soro Ilaya, Lungsod ng Batangas, Maging ang mga nangungupahan (rent) sa nasasakupang ng bawat sityo".

Section 391 of Local Government Code states the powers, duties and functions of the Sangguniang Barangay. First of these powers is to "enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinances to promote the general welfare of the inhabitants therein." The provision of the Code, which is more commonly known as the "general welfare clause" enables the barangays to enact ordinances regulatory in nature and considered as valid exercise of police power since ordinance enacted on the basis of general welfare are deemed necessary to provide for the health and safety of its people and promote prosperity, improve morals, peace, good order, comfort and convenience of the barangay and its inhabitants.


The Barangay Ordinansa Blg. 2, Series of 2019 of Barangay Soro-soro Ilaya is grounded on the grant of power to enact ordinances for the general welfare of its constituents. The ordinance imposes the need to accomplish an information sheet for the necessary data relating to its inhabitants especially those who live in rented facilities/apartments. The barangay is merely exercising its own lawful authority and gives more teeth to the national and local laws.


**RECOMMENDATIONS:**

1. To approve the afore-entitled barangay ordinances;
2. To require the barangay secretaries concerned to submit to the Sangguniang Panlungsod a certification/proof of the public hearing conducted regarding the subject ordinances;
3. To require the Sangguniang Barangay concerned to post copies of their ordinances conspicuous places in their barangay;
4. To adopt this Committee Report.
