



COMMITTEE REPORT

**TO** : The Honorable  
Presiding Officer and Members  
Sangguniang Panlungsod

**FROM** : The Committee on Barangay Affairs

**SUBJECT** : Various Barangay Ordinances of Barangay  
Banaba Center, Batangas City

Referred to the Committee on Barangay Affairs are the following Ordinances:

1. Ordinansang Pambarangay Bilang 01, Serye ng 2019 of Barangay Banaba Center, Batangas City: "Pagbubuwis sa Lahat ng Negosyo at Gawain sa Nasasakupan ng Barangay.
2. Barangay Ordinansa Bilang 02, Serye ng 2019 of Barangay Banaba Center, Batangas City; "Ordinansang Pagbabawal sa mga Ligaw na Hayop at Pagbabawal sa Pagpapaalpas ng mga Alagang Hayop na Nakapipinsala".
3. Ordinansang Pambarangay Bilang 03, Serye ng 2019 of Barangay Banaba Center, Batangas City: "Pagpapabuwis sa Lahat ng Negosyo at Gawain at ang Pagpapakuha ng mga Clearance sa mga Magtatrabaho at sa Mangungupahan na Nasasakupan ng Barangay Banaba Center.

**FINDINGS:**

1. Ordinansang Pambarangay Bilang 01, Serye ng 2019 of Barangay Banaba Center, Batangas City: "Pagbubuwis sa Lahat ng Negosyo at Gawain sa Nasasakupan ng Barangay.
2. Ordinansang Pambarangay Bilang 03, Serye ng 2019 of Barangay Banaba Center, Batangas City: "Pagpapabuwis sa Lahat ng Negosyo at Gawain at ang Pagpapakuha ng mga Clearance sa mga Magtatrabaho at sa Mangungupahan na Nasasakupan ng Barangay Banaba Center.

Local Government Units, including barangay, are granted the power to create their own sources of revenues and collect from the same. The Local Government Code provides:

Sec. 129. Power to Create Sources of Revenue: -  
Each Local Government Unit shall exercise its power to create its own sources of revenues and levy taxes, fees and charges subject to the provisions herein, consistent with the basic policy of local autonomy.

**Likewise, "Sec. 152 (c)" states:**

No city or municipality may issue any license or permit or any business or activity unless a clearance is first obtained from the barangay where such business or activity is located or conducted. For such clearance shall be acted upon within seven (7) working days from the filing thereof. In the event that the clearance is not issued within the said period, the city or municipality may issue the said license or permit.

Section 152 of the Local Government Code of 1991 and Article 240 of the IRR grants the power of the barangay to impose taxes, fees and levies within the territorial jurisdiction of the barangay.

In line with the principles of local autonomy which is the spirit of Local Government Code, Barangay Banaba Center, give effect to the provision of law by tapping their own resources to contribute to barangay development.

Said ordinances set and prescribe the rates of barangay clearance fees, business permit fees and annual barangay tax rates for the use of barangay owned properties to those persons and establishments falling under their taxing jurisdiction as provided by Local Government Code.

2. Barangay Ordinansa Bilang 02, Serye ng 2019 of Barangay Banaba Center, Batangas City; "Ordinansang Pagbabawal sa mga Ligaw na Hayop at Pagbabawal sa Pagpapaalpas ng mga Alagang Hayop ~~na~~ Nakapipinsala".

Section 16, Chapter 2 of Republic Act 7160 under its General Welfare clause states that "Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, Local Government Units shall ensure and support, among other things, the preservation and enrichment of culture, PROMOTE HEALTH AND SAFETY, enhance the right of the people to balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

Said ordinance aims to promote the health and safety of the inhabitants of the Barangay by regulating, penalizing and


prohibiting stray dogs within their territorial jurisdiction. Penalties are also provided for dog owners who in case of an incidence of dog bites or accidents refuse to provide medical assistance to bite victims or fail to comply with the regulations regarding responsible dog ownership.

Finding no legal impediment and having shown its good intention to implement the subject ordinances, the committee hereby recommends:

1. The Adoption of this Committee Report;
2. To require the Sangguniang Barangay concerned to post copies of their Ordinances in conspicuous places in their barangay;
3. To approve the afore-entitled Barangay Ordinances.
