



Program for Duly Registered Cooperatives in the City of Batangas and
Providing for Funds Thereof

COMMENTS/ RECOMMENDATION:

Referred to the Joint Committee on Laws, Rules and Regulations and Committee on Agriculture and Cooperatives is the above proposed ordinance for study, comment and recommendation.
