A RESOLUTION ESTABLISHING THE ABSOLUTE SUPPORT OF THE CITY GOVERNMENT OF BATANGAS TO THE IMPLEMENTATION OF "MARKET TRANSFORMATION THROUGH THE INTRODUCTION OF ENERGY EFFICIENT ELECTRIC VEHICLES (E-TRIKE) PROJECT" BY THE DEPARTMENT OF ENERGY

WHEREAS, the City of Batangas, determined to green its urban transport, recently learned, is absolutely pleased, and expressed its intention for the grant, of the on-going "Market Transformation Through the Introduction of Energy Efficient Electric Vehicles (E-Trike) Project" by the Department of Energy (DOE);

WHEREAS, Batangas City Ordinance No. 4 Series of 2009 entitled "An Ordinance Requiring the Retrofitting of Public Use Tricycles to Meet the Standards of Clean Air Act, Providing Incentives Therefore and for Other Purposes" provides, in its Article II Section 5, for the promotion of the use of electric engine by public use tricycles;

WHEREAS, the Batangas City Ordinance No. 16 Series of 2010 also known as the "Environment Code of Batangas City, commonly referred to as the E-Code, particularly emphasizes in Article VII, Section 39, letters a and b, the use of non-motorized vehicles and electric vehicles as means of adoption of energy efficient and clean technologies and practices. Said provisions also cite the possible designation and opening of roads to non-motorized vehicles;
