**RESOLUTION NO. 9 S. 2020**

**A RESOLUTION ADOPTING THE BATANGAS CITY COMPREHENSIVE LOCAL  
JUVENILE INTERVENTION PLAN (CLJIP) 2019-2021**

**WHEREAS**, the Department of Social Welfare and Development (DSWD) National Government through the Regional Juvenile Justice Welfare Council requires Local Government Unit (LGU) for the implementation of programs and services for the protection of Children in Conflict with the Law and Child at Risk per R.A. 9344 as Amended by R.A. 10630 – The Juvenile Justice Welfare Act which aim to provide a just, humane and more systematic procedures on how to handle cases of Children in Conflict with the law;

**WHEREAS**, the City Government of Batangas, in its endeavor to promote the rights of Children and protect them from abuses, has formulated four (4) important documents in achieving the objective of R.A. 9344 and these include the Local Development Plan that was enacted in 2001; the City Development Plan for Children; the State of the Children’s Report and the formulation of Comprehensive Local Juvenile Intervention Plan 2019-2021;

**WHEREAS**, the said Comprehensive Local Intervention Plan 2019-2021 is another milestone in the history of the City in providing a just and humane system of treating Children in Conflict with the Law;

**NOW THEREFORE**, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session duly assembled by virtue of this resolution, subject to all existing laws, rules and regulations, to adopt the Batangas City Comprehensive Local Juvenile Intervention Plan (CLJIP) 2019-2021.



**COMMENTS:**

The subject request for the approval of the Batangas City Comprehensive Local Juvenile Intervention Plan (CLJIP) 2019-2021 was referred to the Joint Committee on Laws, Rules and Regulations and Committee on Social Welfare for its consideration during the Regular Session on December 4, 2018.


