RESOLUTION NO. 37 S. 2020

**RESOLUTION REQUESTING THE CITY ENGINEER’S OFFICE TO IMMEDIATELY
PROVIDE ADDITIONAL PEDESTRIAN LANES ON VARIOUS STRATEGIC
LOCATIONS IN BATANGAS CITY AND TO RESTORE THE ALREADY IN
PLACE BUT SLIGHTLY FADED LANES**

WHEREAS, Section 16 of RA 7160 known as the Local Government Code of 1991 provides that every Local Government Unit shall promote the health, welfare, safety and convenience of its residents, hence, the Local Government Unit shall exercise the power to provide and ensure the convenience and safety of the general public;

WHEREAS, on January 8, 2020, Batangas City Mayor Beverley Rose A. Dimacuha and Congressman Mario Vittorio A. Mariño reiterate their eagerness to launch the “Eto Batangueno Disiplinado-Magkatuwang Tayo” Program of the Batangas City Government; hence, part of the “Eto Batangueno Disiplinado – Magkatuwang Tayo” program is the proper implementation of Pedestrian Lane rules for the safety and convenience of our constituents;

WHEREAS, to properly implement and support the said program, the Batangas City Government viewed the need to appropriate additional pedestrian lanes on markless streets/roads where volumes of people cross by everyday and to repaint slightly faded existing pedestrian lanes.




