WHEREAS, through the Resolution No. 35 Series of 2013, the Sangguniang Panlungsod, Batangas City have approved and passed the San Gabriel Phase III Power Plant Project (the Phase III project) on February 18, 2013;

WHEREAS, the planned capacity of the project has increased to 1260 MW as it will use the latest, higher capacity gas turbines with unprecedented high efficiencies and better operating flexibility contributing to a more stable grid. 

RENAMING THE 990 MW SAN GABRIEL PHASE III POWER PLANT TO SANTA MARIA

COMBINED CYCLE POWER PLANT

COMMENTS:

The subject request for the adoption and confirmation of the new name of 990 MW San Gabriel Phase III Power Plant was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on December 16, 2019.

Through the Resolution No. 35 Series of 2013, the Sangguniang Panlungsod Batangas City have approved and passed the San Gabriel Phase III Power Plant project (the Phase III project) on February 18, 2013. The said project has since been re-named as the Santa Maria Power Plant, but still be located within the First Gen Clean Energy Complex in Barangay Sta. Rita Aplaya and Sta. Rita Karsada, Batangas City. Furthermore, the planned capacity of the project has increased to 1260 MW as it will use the latest, higher capacity gas turbines with unprecedented high efficiencies and better operating flexibility contributing to a more stable grid. Hence, the former Phase III Project will be officially known as the 1260 MW Santa Maria Combined Cycle Power Plant project when commenced and completed by First Gen EcoPower Solutions, Inc., a fully-owned subsidiary of First gen Corporation organize to undertake its development.
