UTILIZATION OF LDRRM TRUST FUND FOR THE PURCHASE OF SUPPLIES TO CONTROL  
EPIDEMICS/PANDEMICS, VETERINARY SUPPLIES, DISINFECTANTS AND VACCINATIONS AND  
MEDICAL SUPPLIES, PPEs AND DISINFECTANTS TO PREVENT THE SPREAD OF DISEASES IN  
HUMANS AND ANIMALS WITH A TOTAL OF FIFTY-ONE MILLION PESOS (P51,000,000.00)**
