WHEREAS, Batangas City is placed under Enhanced Community Quarantine starting March 18, 2020;

WHEREAS, there is a need for the Sangguniang Panlungsod to sustain delivery of services to its constituents most specially during this time of health emergency;

WHEREAS, technology presents alternative platforms for the holding of conferences, meetings, or sessions on-line;
